The Fight to Save Long Creek is Not Over!

Our tranquil little corner of Virginia Beach was recently threatened by the possible construction of a dredge material transfer site on Long Creek, right next to Marina Shores Marina (The Maple Street site).

We won a significant battle at the Board of Zoning Appeals (BZA) hearing last September, 2011. The BZA's opinion: Maple Street is not a permissible site for a permanent dredge spoils facility for a variety of reasons. The City appealed the BZA's ruling to the Virginia Beach Circuit Court, requesting that the court overrule the BZA determination. That case is pending and has yet to be heard.

On the heels of the BZA ruling, the Beaches and Waterways Commission reported to the City that the Maple Street site was not a good fit for the dredge spoils facility location. Another win for our community.

The City passed a resolution stating that they would remove Maple Street from the City's Neighborhood Dredge Program. However, the City refused to withdraw their appeal of the BZA determination AND refused to withdraw their request for a permit to

dredge Long Creek by both mechanical and hydraulic methods.

The Marine Resource Commission (VMRC) granted an extended permit that would allow the City to dredge and transfer a large amount of material at the same Maple Street site. It seems the City is determined to make this a dredge transfer station, even if the citizens who live next door are strongly opposed to it.

We need your help to preserve the Maple Street site!

Ask the Virginia Beach Circuit Court to uphold the BZA determination in our favor. The "Maple Street Legal Fund" has been established to help with legal fees involved in moving ahead with the Circuit Court appeal. We greatly appreciate any financial donation you can make to help save Long Creek.

Write, call, and email the Mayor and City Council members. Tell them you DO NOT want a dredge material transfer station at the Maple Street site.

City Ordinances

Due to neighborhood inquiries; here is some information regarding current City ordinances concerning "Open Fires" and "Beach Obstruction". (A recent City Attorney opinion says this includes volleyball poles):

Sec. 6-2. - Obstructing beach.

It shall be unlawful for any person to put, place or set any equipment, such as dugouts, chairs, umbrellas, windbreakers, surfboards, air floats, life rafts or similar paraphernalia not actually occupied or engaged, or to build or erect any fence or other obstruction on any public sand beach, so as to obstruct, impede or retard the free and unconstrained use and occupancy of such sand beach by the public. (Code 1965, § 6-3)

Outdoor Fireplaces

A fairly new product called an **outdoor fireplace** is creating some confusion in the application of the Open Burning Ordinance. Based on the ordinance the use of outdoor fireplaces will be treated as any other open burning such as recreational fires, cooking/grill fires and campfires. The use of this device should be in accordance with the manufacturer's guidelines.

1. Any outdoor fireplace creating a smoke nuisance shall be extinguished.
2. Only clean dry firewood shall be used as a fuel.
3. The outdoor fireplace must be not less than 15 feet from any structure.
4. Fire shall be constantly monitored until extinguished.
5. Fire extinguishing equipment shall be available.

Attached are excerpts from the Open Burning Ordinance that were referenced. **City Ordinance 12-3**

- (a) Except as otherwise provided in this section, no person shall ignite or maintain, or cause or permit to be ignited or maintained, any open fire on public or private property outside any building. Salvage, demolition operations or disposal of waste materials by burning is prohibited.

Exceptions:

- (2) Fires may be used for cooking food, provided no smoke violation or other nuisance is created.
- (3) Salamanders and similar heating devices may be used for heating by outdoor workers provided no smoke hazard or other nuisance is created and provided that such devices are used not less than fifteen (15) feet from any structure.
- (4) Open fires may be set, other than on any sand beaches, for recreational purposes, or for ceremonial occasions, provided that no smoke violation or nuisance is created.
- (5) Open burning shall be prohibited for land clearing, except agriculture operations. However, the provisions of this section shall not prohibit controlled force-air pit burning of brush, leaves and trees from land clearing operations conducted under authority of a permit issued by the chief of fire protection or his designee; provided that such burning shall be in conformance with procedures approved by the chief of fire protection and the department of environmental quality (air division), and shall be immediately terminated upon revocation of such permit. Compliance with the provisions of this subsection shall not exempt any person from any damages or liability which may result from such open burning, nor exempt any person from adherence to all applicable laws, ordinance and regulations and orders of the chief of fire protection and the state forester.

City Ordinance 12-4

- (a) Open burning, where permitted by this chapter, shall be constantly monitored until the fire is extinguished. Fire extinguishing equipment shall be available for immediate use.
- (b) The chief of fire protection shall prohibit open burning, otherwise lawful, when smoke may cause reduced visibility on any highway, or when emissions or odors may constitute a hazard or nuisance. The chief of fire protection shall order the extinguishing by the permit holder or other responsible person, or by the fire department, of any fire which creates such a hazard or nuisance, or if adjacent property is considered to be endangered.

City Ordinance 12-5

It shall be unlawful and a Class 1 misdemeanor for any person to set fire to or to procure another to set fire to any wood, brush, logs, leaves, grass, debris or other flammable material at any time on any sand beach of the city.

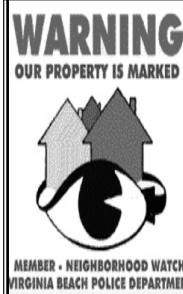

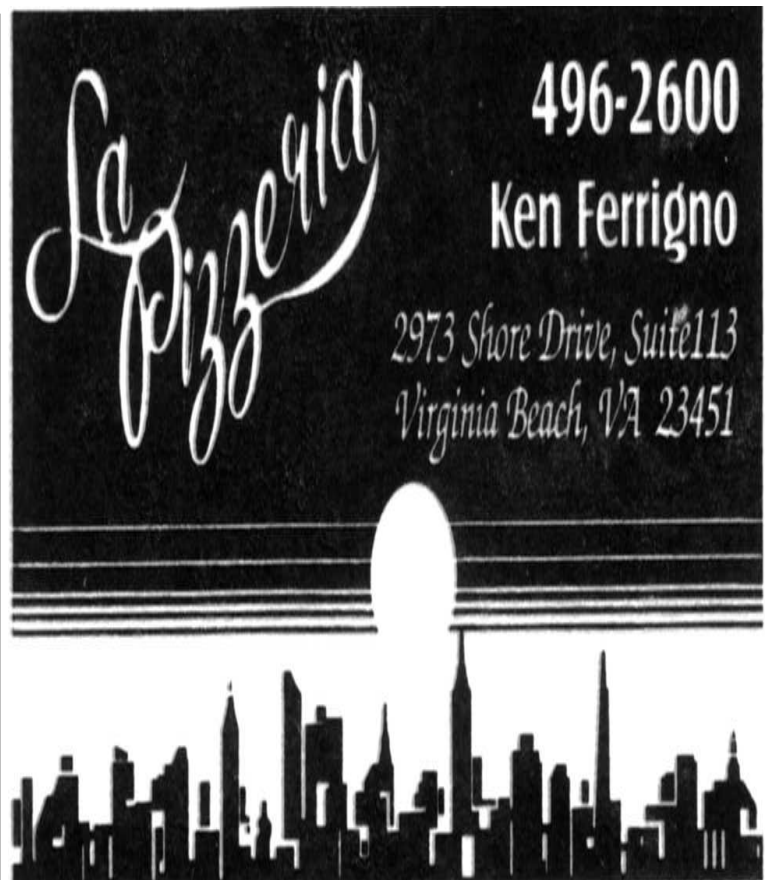
