Fireworks – 9:20pm @ Cape Story Beach**

This year's parade and brunch will take place from 10:00 am to 12:00 pm (noon) on Saturday July 4th. The parade route will start on Beech at the bike path, proceed down Beech to Poinciana, follow Poinciana to Bayberry, turn left on Bayberry and end in the neighborhood park. All bike riders, floats and marchers need to line up for the parade between 9:30am - 9:45am. Please be careful spilling out onto Shore Drive. If you have to, line your float up in Bloom's parking lot and we will work you into the parade as it starts moving.

This year's parade theme, determined by votes at the Spring Fling, is *"The American Revolution"*. Awards will be given for Most Original, Most Patriotic and Best Theme. Bribing the judges is greatly encouraged! The parade will be followed by a brunch in the park. There will also be biscuits, doughnuts, fruit and patriotic tunes performed by the "Acoustaholics".

The annual fireworks show will once again be presented by Zambelli Fireworks Internationale. The display will consist of over 700 shells and will be launched around 9:20 pm on Saturday July 4th from the beach at First Landing State park. The rain date will be Sunday July 5th at the same time. Please pass the word that personal fireworks should not be launched until after the show. Use of personal firework before the show may result in cancellation.

Volunteers are still needed for all of the 4th of July events.

- Fireworks set-up and clean-up – Trucks and movers are asked to arrive at First Landing at 1:00pm.

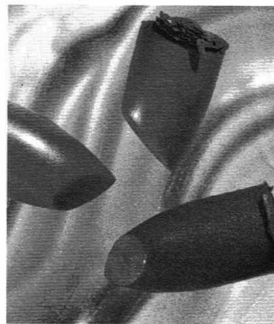

What You Should Know About Solicitors at Your Door

The following is an excerpt from Virginia Beach Police Department publication “Behind the Badge, dated February 2008.

Virginia Beach City Code, Sec. 26-26(a), requires door-to-door solicitors to have a copy of the City issued solicitor’s permit with them at the time they are soliciting. The permit should contain a recent photograph of the solicitor presenting it. Some businesses, such as charitable, non-profit organizations, and civic or religious organizations, are exempt from this requirement. Sec 26-26(b) is a complete list of those organizations and individuals exempt from the solicitor’s permit requirements—

Sec. 26-26. Permit required.

(a) It shall be unlawful for any person to engage in soliciting, selling or taking orders for goods, wares, merchandise, publications, any article for future delivery, or any service or commodity whatsoever, on the public streets, ways, lanes or alleys or in any other public place adjacent to the same, or upon the premises of any private residence or apartment house not having been requested or invited to do so by the owner or occupant thereof, in the city, unless he has a current permit so to do from the city manager.

(b) The requirements of this section shall not apply to those who sell or offer for sale in person or by their employees ice, wood, charcoal, meats, milk, butter, eggs, poultry, fish, oysters, game, vegetables, fruits or other family supplies of a perishable nature or farm products grown or produced by them and not purchased by them for sale; persons licensed by the state under title 38.1 off the Code of Virginia (1950), as amended; persons licensed by the Virginia Real Estate Commission, pursuant to section 54-749 of the Code of Virginia (1950), as amended; such activities when they are conducted on behalf of a nonprofit charitable, civic or religious organization; outdoor sales and exchanges which occur as an incidental part of the retail sales activity of a merchant regularly conducting business from a permanent building where such sales are conducted on the premises of the building and in close proximity to said building; occasional garage sales in residential areas; sales made at flea markets duly licensed by the city; or sales by wholesale merchants to retail merchants or industrial or commercial establishments.

(Code 1965, § 18-4; Ord. No. 1410, 10-24-83; Ord. No. 1456, 6-4-84)

Remember—report all suspicious individuals and activity to the Police non-emergency number (385-5000) or for actual crimes, call 911. Never allow solicitors into your home, and verify their identity before opening your door. Trust your instincts—if you feel uneasy, ask them to leave your property. # Shore Drive and City News Update

**Indigo Dunes Project** – Nothing is moving forward regarding any of the environmental permits or the City's Circuit Court appeal. The property is rumored to have been taken over by the controlling bank. The City has also begun discussions with the bank for the cash purchase of the property. It appears the economic downturn has helped slow or stop the proposed high density development that was planned. The SDCC has begun working on a plan to make the property a natural open space and environmental research center - something similar to the Rice Center at VCU. **Update on Lesner Bridge Replacement** – The SDCC, BAC and City Staff and City Council had initially chosen the southern alignment proposal. After a presentation by the owner of Bubba's and the Pilot's

Association, City Council picked the northern alignment as the plan to build. The SDCC and owners of 3556 are in discussions with the City to find a compromise design that will build a smaller bridge and keep it equal distance from the concerned residents at both ends of the bridge.

**Pound Pole Fishing Nets** – The Virginia Marine Resource Commission (VMRC) approved 2 permits for 3 new nets located west of the Lesner Bridge. Ocean Park residents have appealed the VMRC decision to the Circuit Court of Virginia Beach. There has been no hearing date set.

**Sand Replenishment Update** – The City and the US Army Corps is working toward a dredging date of this winter 2009/2010. The material dredged from the Lynnhaven Inlet will be deposited on the beach from Jade Street to Kendall Street. The VMRC still needs to approve the plans before the work can proceed.

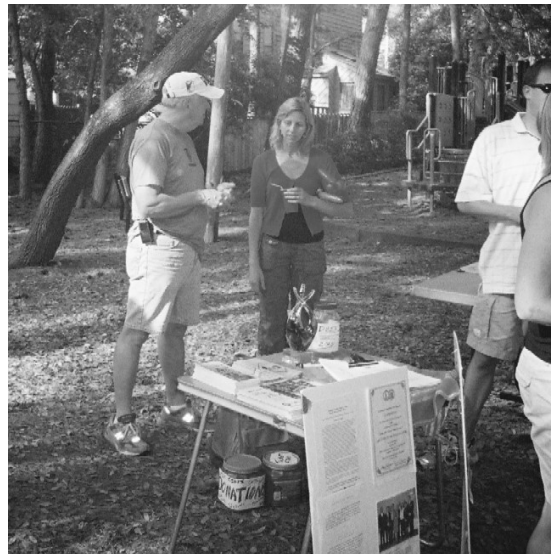

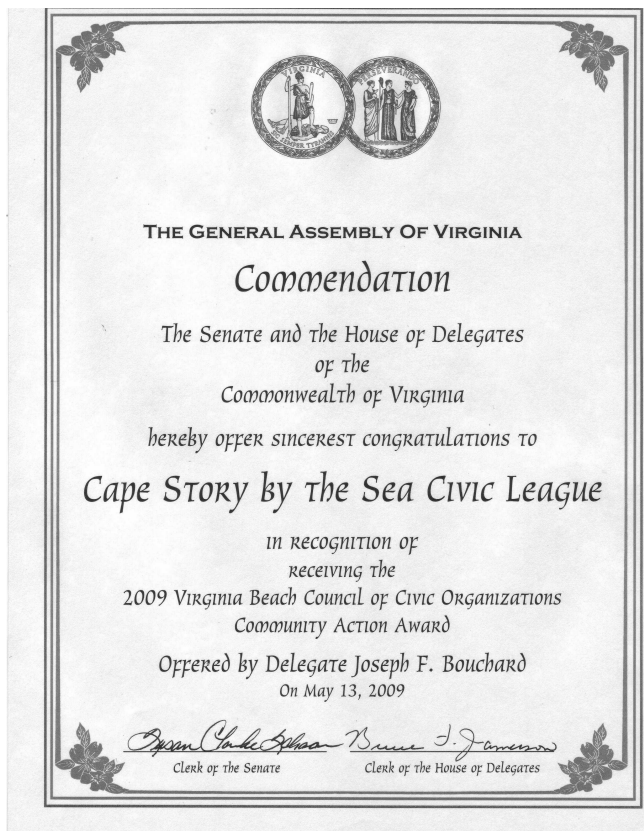

For those vehicles without DoD decals and IDs, the procedure will still be for everyone in the car older than 16 to show a valid government-issued ID. Those coming on post still need to have valid insurance and registration on the vehicle.

We want to thank all of you for your great show of support on Shore Drive during the early morning hours of May 2 when the platoon from the 368th Transportation Company left for Iraq from Fort Story. The Soldiers greatly appreciated being sent off with the flags, signs and waves from all of you. Your organization never ceases to amaze us when it comes to supporting our troops.

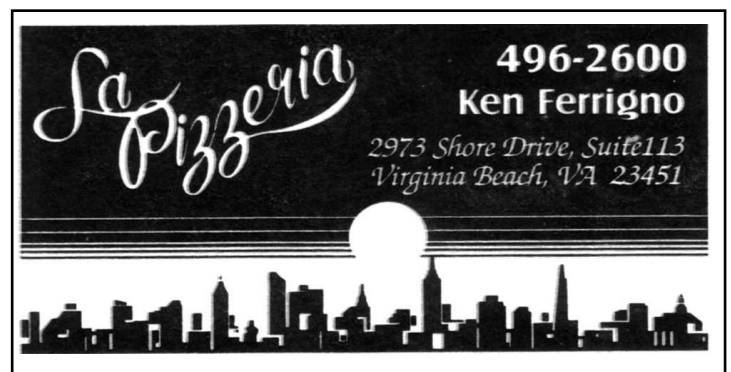

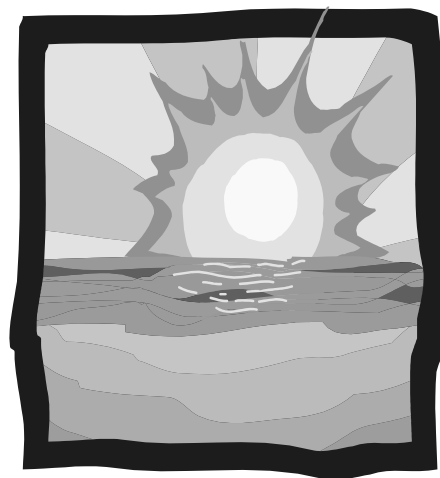
