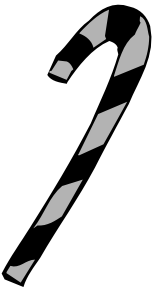

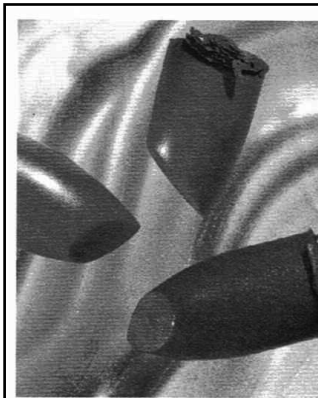
## Cape Story Carolers

# Shore Drive and City News Update

Todd Solomon, President of the Shore Drive Community Coalition

**Indigo Dunes Project** – The Department of Environmental Quality (DEQ) has provided recommendations to the State Water Control Board (WCB). The WCB hearing has been deferred for Nov & Dec at the developer's request. The SDCC Pleasure House Point (PHP) committee and its legal representation are continuing to work on a plan for the WCB hearing.

**Lynnhaven Boat Ramp (LBR) Proposed Spoils Transfer Station** – The LBR is not the primary location anymore for the dredge transfer station for the western branch of the Lynnhaven. City Staff is still pursuing the purchase of land behind the AT&T store (4338 VB Blvd.) just off VB Blvd as a possible transfer site. This site would also provide kayak & canoe access when not being used as a transfer station. City Staff is looking at purchasing or condemnation of all the property in the area to also allow a Fire Station.

**Proposed Rezoning of City Marina** - At the public's and SDCC's request, the proposed rezoning and privatization of this property has been removed. The SDCC has asked that any future plans for this property be discussed by a committee consisting of the adjacent neighbors, the current slip owners, adjacent business owners, the SDCC, the BAC and City Staff.

The SDCC has also asked the Bayfront Advisory Committee to take the lead on any future discussions.

**Proposed Pound Pole Net Licenses** – During the month of October, 4 applications were submitted to the Virginia Marine Resource Commission (VMRC) to build new pound pole nets off the shores of Cape Henry beach. 2 of the new nets would be located in the State Park, one would be located near Bayberry Street and the 4<sup>th</sup> would be near the Landings Condominiums. The SDCC will be discussing the impact of these types of nets to the community, the marine life in the Chesapeake Bay and the fishermen's livelihoods. Should additional nets be prohibited or are these waters public and open to all? The SDCC has also asked the BAC to discuss this issue and take a position for the Bayfront and Virginia Beach.

**Additional acreage in the Lynnhaven River open to oyster harvesting** – Recent reports say that 31% of the Lynnhaven have been cleared up enough to allow oyster harvesting to begin again. A big thank you to the Lynnhaven River NOW organization and to all of you that have been making a big difference in the restoration of the Lynnhaven River.

# Park Beautification/Adoption

## WILDLIFE REHABBERS

Hampton Roads has many experienced wildlife rehabbers who hold a STATE PERMIT to do so. IF YOU FIND orphaned or injured wildlife, PLEASE do the following:

1. RESCUE the animal, quickly. Place the animal in a softly-lined covered box with ventilation, or a secure animal crate. Make sure the animal cannot escape but DO insure it has ventilation (air!).
2. Place the box in a warm (preferably, not in an area with chilly A/C), dark quiet indoor location away from all humans and pets. Stress kills many animals! Keeping it in a quiet, dark place is essential.
3. Do Not attempt to give it food or water, no matter how much it begs! (THIS is very important. Many many injured animals are accidentally killed by kind-hearted folks who insisted on giving the animal food or water. Please, do not!)
4. Make arrangements to transport the bird or mammal to a permitted facility or rehabilitator as soon as possible. Call 757-263-4762. This will require some patience and a pencil and paper. You will be guided through a system asking you what kind of animal you've found, etc., and then you will be given the address of the animal wildlife rehabber that SPECIALIZES in the care of that type of animal. Please take the animal (if driving conditions are safe) to that rehabber as soon as is safely possible. The quicker you can get it to the rehabber, the better the animal's chances.

"I know, that was a good thing you did today Daisy!"

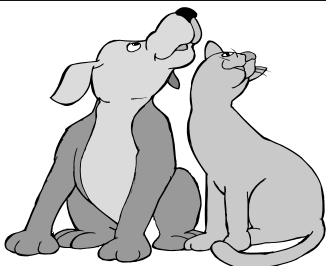

# A Letter from Ft. Story

Greetings Cape Story by the Sea Civic League members,

It seems the old saying "The only things that stay the same are things always change" is nowhere more true than at Fort Story.

Nov. 21 we had a change of command where Lt. Col. Sean Herron, outgoing garrison commander, relinquished duty to Lt. Col. Jayne Jansen, incoming garrison commander and the first woman garrison commander of Fort Story.

Herron returned to Fort Eustis to take up his new position as the director of the Office of the Chief of Transportation. Jansen comes to Fort Story from her last assignment in Plans for the Army Sustainment Command at Rock Island Arsenal in Rock Island, Ill. She hails from Minnesota where she graduated from Mankato State University with a Bachelor of Science degree in Sociology, and later she graduated from Minnesota State University with a Master of Arts degree in Public Administration. Her military education includes the Transportation Officer Basic Course, Combined Logistics Officer Advance Course, Combined Arms Service Staff School and General Staff College. Her military awards include the Bronze Star Medal, Meritorious Service Medal, Army Commendation Medal, National Defense Service Medal, Afghanistan Campaign Medal, Global War on Terrorism Medal, Combat Action Badge, Parachutist Badge and the Order of St. Christopher. Jansen said she looks forward to meeting all of you soon in an upcoming Cape Story by the Sea Civic League meeting.

Also, since the last letter, Fort Story civilian employees met the new Joint Expeditionary Base Little Creek – Fort Story commander, Navy Capt. Bill Crow, during a town hall meeting to discuss Joint Basing. Fort Story will start initial operating capability under the Navy in January. Venassia Gunter, 11th Transportation Battalion family readiness support assistant, led up an effort sponsored by the 1st Advantage Federal Credit Union to send cookies and other treats to the Soldiers. Community organizations like Salem High School and Ocean Lakes High School donated cookies and helped pack boxes to send. Fort Story, with the help of the local community, sent 123 dozen cookies and treats to Soldiers for the holidays.

# Neighborhood Watch

## **Oct. 14<sup>th</sup> Bike Path Accident** **Is the bike path safe?**

A young man riding a bike was struck by a vehicle on Tuesday Oct 14<sup>th</sup> at approximately 9:30 a.m. at the intersection of Wake Forest Street and the bike path. The biker did not stop at the cross street but fortunately the vehicle was going slow and the biker was not hurt. This is the third known incident of this nature in the past 2 years.

The Cape Story by the Sea Civic Association has asked the City to evaluate what can be done to make the bike path safer for bikers, walkers and drivers. City Staff will present the possible options at the January 12<sup>th</sup>

2009 general meeting (see calendar of events). Past discussions on this issue have brought up the following suggestions:

- Stop signs for vehicles at the bike path on the long streets (Beech, Oak, Maple, Sandalwood, Bayberry, Wake Forest and Kendall).
- Speed bumps at the bike path on the long streets (Beech, Oak, Maple, Sandalwood, Bayberry, Wake Forest and Kendall). In the past, the City Fire Department would not allow speed bumps in our neighborhood.
- Increased education of the residents through the newsletter, direct mailings and on-site programs.
- Landscape trimming to enhance visibility for drivers and persons on the bike path. The City is proceeding with this in areas where they have the right of way.
- Stop signs at each long street along the bike path route. These are currently installed.
- Additional bike path caution signs on the long streets. These are currently installed.

If you are concerned about the safety conditions along the bike path, if you have an additional suggestion or if you have an opinion about adding stop signs at the bike path on the long streets, you are highly encouraged to attend the January general meeting at the Resort Conference Hotel.
