

# Shore Drive and City News Update

Todd Solomon, President of the Shore Drive Community Coalition

Indigo Dunes Project – The United States Army Corp of Engineers (USACE) is reviewing the application for the Joint Permit Application #2 (JPA). The Shore Drive Community Coalition (SDCC) submitted an opposition report and asked for a public hearing and all information on the project via a Freedom of Information Act (FOIA) request. The USACE denied the SDCC FOIA request and has stated that a public hearing is not required. The SDCC obviously disagrees with this and has appealed. Also, there has been no date set for the State Water Control Board hearing on JPA #2 or the circuit court appeal of JPA #1 by the City of Virginia Beach.

<u>Update on Lesner Bridge Replacement</u> – A Community Information Meeting (CIM) was held on Feb 11th at Cox High School and attended by about 50 residents. The main focus of this meeting was to present the 30% design drawings and to have the residents comment on the north or south alignment proposals. The northern alignment is estimated to cost \$67 million with a requirement to purchase some of the old Duck-In property, creates a jog on the western side and relocates the emergency driveway of 3556 by the Bay. The southern alignment is estimated to cost \$69 million + \$5 to \$11 million to relocate the high tension power lines. This alignment has no property impacts and a smoother route. City Council needs your input to make the final decision.

Pound Pole Fishing Nets – The Virginia Marine Resource Commission (VMRC) denied the first two applications at their Nov. meeting. The 3rd application has been withdrawn, but the 4th application still remains. If the remaining application is publicly posted, the VMRC will hear this application within 30 days of the public notification. VMRC denied the applications by a vote of 9-0 based mainly on the documented deaths of about 4 dolphins per year from these types of nets.

<u>Oyster Restoration Project</u> – The USACE is reviewing a plan on whether or not to allow the introduction of sterile Asian oysters into the Chesapeake Bay. The SDCC sent a letter to the USACE supporting the Lynnhaven River NOW (LRNOW) and Chesapeake Bay Foundation (CBF) position of native oysters only.

City and Bayfront Advisory Committee (BAC) Tree Planting Project – City Staff is putting together a map showing City owned property that can be used for land-scaping improvements. Shore Drive residents are being asked to review this map and help identify areas they would like improved with tree, bush and flower plantings.

Relocation of Chick's Beach Fire Station – The City has recently purchased the old Texaco gas station at the corner of Shore Drive and Northampton Blvd. The Fire Dept is working on preliminary designs for the new station, but lacks funding for actual construction. BAC is worried about the size and access of the lot to support a fire station. Two other sites were looked at, North Oliver and just west of the Walgreen's on Pleasure House Rd., but did not have willing sellers.

# A letter from the Commanders Dear Cape Story by the Sea Civic League members,

HOOAH and Go Navy! One team, one mission! We've finally commenced implementation of our Joint Basing efforts, and so far, the merging of both our outstanding services is going great! Feb. 1 saw the Initial Operating Capability transfer of more than 10 staff functions. Employees within those functional areas are working together to continue to provide the best customer service possible with the focus of maintaining a seamless transition. May 1, we will continue our merger with 10 more staff functions making the transition. This will be followed by about another 10 functions merging on Aug. 1. All this leads up to the Final Operational Capability on Oct. 1 and the formal establishment of Joint Expeditionary Base Little Creek-Fort Story.

During this transitional period, it is important for us to remain transparent in our efforts to the local Virginia Beach community. We want to assure those who have any concerns about changes to either Naval Amphibious Base Little Creek or Fort Story that we are committed to preserving the strong relationships both our military installations have with the great City of Virginia Beach, its citizens and visiting tourists. You will hear quickly and directly from our staffs if any changes need to be made in order to better serve our military personnel, family members and civilian employees. Let us assure you, when making decisions about the wellbeing of the installations and its members; we never forget to consider those outside our gates.

In remembering those outside the gates, we have seen ourselves or have seen photos of how much the CSBTS Civic League supported our troops when they were leaving or coming home. # Neighborhood Watch

#### **Bike Path Safety**

City representatives, including Fire and Police personnel and Councilman Jim Wood, attended our January meeting to discuss traffic safety concerns with Cape Story residents. The following is a summary of comments and possible solutions:

- 1. Stopping at the cross street intersections in CSBTS is the responsibility of the path user (stop signs posted) as well as the vehicular traffic (yellow caution signs posted) but frequently only casually observed resulting in "near misses" and/or unreported accidents. Only TWO bike path/vehicle accidents have been REPORTED since 2006. IF YOU DO NOT REPORT ACCIDENTS THEY DID NOT HAPPEN.
- 2. MOST Residents respect the bike path and slow or stop. Visitors and construction workers not familiar with

the area frequently do NOT.

- 3. Placing "Stop" signs on the cross streets for vehicular traffic is a concern for police (difficult to enforce) and city engineering officials. Discussion on changing of the yellow signs with pedestrians and children being changed to YIELD signs was not resolved. Use of Speed Bumps and Rumble strips did not receive support from Police, Fire or City officials.
- 4. The use of median changes with optical and/or median obstruction/islands with vehicular and BIKE/Runner required to travel around the median to the sides of the road/trail (forcing a slowdown) received the most support from city, police, fire officials as well as a number of CSBTS members. Some areas of the city have similar "obstructions" to slow traffic including adding serpentine fencing and landscaping on the bike path to make pedestrians slow down before entering the cross streets.
- 5. A possible mock up of what such a diversion of street/path traffic would be was suggested for Bayberry and Sandalwood intersections and CSBTS would notify homeowners next to the park of the trial mock diversion (temporary paint, makers on street, park etc.) to assess the results of this plan.
- 6. Homeowners whose foliage and trees obstructed views at the intersections and bike path would be notified to cut back the obstructions before the city acted to clear the area.
- 7. Speed limit of 45 on Shore Drive continues to be an issue with the traffic engineer surveys continuing to indicate that 45 mph is the "appropriate" speed for Shore Drive from Great Neck to First Landing Park. CSBTS and SDCC continue to challenge this assessment especially with the new fire/rescue station in the corridor. A petition to city council may be a possibility.

Dialogue with City officials and possible solutions will continue to be an agenda item for CSBTS monthly Meetings.


