Minutes for the April 10, 2017 Cape Story by the Sea (CSBTS) General Meeting at the Resort Conference Hotel submitted by Todd Solomon

Meeting Start: Called to order at 7:31 pm by President Diana Albis. 30 attendees were present.

Special Presentation – Marina Shores Proposed Apartment Development – Ms. Lisa Murphy provided an update on the proposed plan to build 200 apartments on the existing site. Original plan called for 261 units. New plan reduces that number to 200 and eliminates the need for a 2nd entrance to be built on the eastern side (sand pit access road). The new plan calls for the wetlands area south of Wake Forest St. adjacent to Long Creek to be designated non-buildable P-1 Natural Area and turned over to a non-profit within 18 months of plan approval. The non-profit would control the public access to the Natural Area. A question was brought up regarding the 100 ft easement that has been designated for dredge material transfer possibilities. Ms. Murphy ensured attendees that this area will become a proffer and included in the non-buildable P-1 Natural Area. She promised that this would be added to the plan wording prior to any hearing. The developer will present to BAC on May 18th and to the Planning Commission no earlier than July.

Officer Reports:

Secretary Report: Minutes were submitted by Todd Solomon for the March meeting. A motion was made by Dick Brothers to accept the minutes as written. A second was made by Tosh Cohoon. The motion passed unanimously.

<u>Treasurer's Report:</u> Report submitted by David Albis, presented by Diana Albis and accepted. \$22,961.15 total funds in Cape Story Accounts and \$1,438.98 in the Fireworks account.

1st V.P. Report: Fort Story will be holding its annual Easter Sunday Sunrise Service. Art show in First Landing State Park had a good turnout. VBCCO – No new update. They are still looking for help and floundering. City of VB will be holding public hearings in April/May regarding the annual budget. BAC's May 26th meeting will have an art presentation for a display to be placed at Lesner Bridge. May 18th meeting will be extended to allow Civic Group Representatives a chance to identify issues.
