- <u>Pound Net Permit Applications</u> The Virginia Marine Resource Commission(VMRC) denied the two Oct 9th applications at their November meeting. The next hearing for the two Oct. 31st applications will be heard at the Jan. 27, 2009 VMRC meeting at the earliest. VMRC denial was based mainly on adverse impact to dolphins in the Bay. On average, pound nets kill 4 dolphins per year according to the Virginia Aquarium data.
- Holiday Giving Nancy Snyder CSBTS coordinator reported that the new deadline for Christmas giving is Dec. 21st.
- Cape Santa in the Park Event will be held Saturday Dec. 13th at 2pm in the Cape Story Neighborhood Park.
