Old Business:

Marina Shores Development – The City Attorney is reviewing the application and its proffers. What will happen to the 100 foot easement that is used for dredging is a big issue and needs to be followed.

June 26^{th} – City staff to present update on FEMA/HUD Community Rating System (CRS) for flood insurance premium reduction.

Shore Drive American Flags – Flags and flag poles have been damaged by storms. A motion to spend \$300 to buy necessary replacements was made by Todd Solomon and 2nd by Ginnie Stover. The motion passed unanimously.
