Minutes for the April 9, 2018 Cape Story by the Sea (CSBTS) General Meeting at the Resort Conference Hotel submitted by Todd Solomon

Meeting Start: Called to order at 7:35 pm by President Diana Albis. 30 attendees were present.

Special Discussions -

Short Term Rentals (STRs) – Historic background on STRs and the City's study and recommendations was shared. The City's website on the topic shows a matrix of 5 possible alternatives. Vice Mayor Jones recently made a sixth which is alos posted on the City's website. All alternatives include regulations being added to city ordinances that control parking, noise, trash, and other issues. One of the big topics of discussion is if STRs should be required to apply for Conditional Use Permits (CUPs). This requirement varies among the alternatives. Attendees questioned how the City plans to enforce any new regulations. The City is looking into it, but no details have been shared. Some members heard that the City's 311 service would be used to control complaints and inquires. It was also asked if STRs could be subleased, but nobody had an answer.

Kendal/Cape Henry Trail Storm Water Project – Todd and Kathy provided an update on the Kendall St. sidewalk and Cape Henry Trail stormwater ditch project. A sidewalk is being added to the eastern side of Kendall St. A large retention swale is being dug in the City's right of way south of the Cape Henry Trail between Kendall and Calvert. 30+ trees were cut down, but 120+ trees will be planted around the swale. The swale was oversized to allow the City to create a mitigation bank for other City projects that couldn't meet increased capacity requirements. Lack of City notification to adjacent property owners seems to have been an issue with this project. CSBTS should learn from this for future City projects in our neighborhood.
