# Minutes for the February 13, 2023 Cape Story by the Sea (CSBTS) General Meeting at Lynnhaven Colony Congregational Church submitted by Todd Solomon

Officer Reports:

Secretary Report: January 9, 2023 minutes were distributed for approval. A motion to approve with no changes was made by David Albis and 2<sup>nd</sup> by Tosh Cohoon. The motion passed unanimously.

The Virginia Beach Council of Civic Organizations (VBCCO) is resurrecting and will be electing a new slate of officers. Civic groups are being asked to rejoin for \$25 membership dues.

## **New Business:**

VBCCO Membership – A motion to join the VBCCO and pay the \$25 membership dues was made by Tosh Cohoon and 2<sup>nd</sup> by Empsy Munden. The vote passed unanimously.

**Trees Planted in Cape Story Park** – Two new trees were planted in the park by City's Parks and Rec department. No contact with Civic Association prior to planting. Location of trees is problematic and potentially dangerous. Mr. Parkman, Parks and Rec. and Councilman Taylor will be contacted and asked to remove or relocate the trees.

**Volleyball Poles Removed from Cape Story Beach** – City's Public Works removed all of the volleyball poles from the beach. Some of them were taken to 1401 Parks Ave. and can be retrieved. The Civic Association wasn't notified prior to removal. The City has been asked why this didn't happen.

**District 8 Councilman Taylor Town Hall** – A town hall is scheduled for Thur. Feb. 16<sup>th</sup> at Great Neck Rec Center from 6:30pm to 8:30pm.

**Whale Carcasses** – A humpback whale carcass washed ashore near Kendall St. and a right whale carcass came ashore in Ocean Park. Residents are asked to keep distance while the bodies are disposed.

Speakers at Membership Meetings – The suggestion was made to start having speakers at civic meetings to raise attendance. We used to have speakers in the past and should do so again now that COVID concerns have diminished. The first speaker request was made for a rep from the Senior Services of Southeastern Virginia or the City's Senior Resource Center.
