# Minutes for the May 13, 2024 Cape Story by the Sea (CSBTS) General Meeting at Lynnhaven Colony Congregational Church submitted by Todd Solomon

Meeting Start: Called to order at 7:34 pm by President Diana Albis. 15 attendees were present.

<u>Special Presentation/Guest:</u> Diana Howard, Chair of the Virginia Beach Tea Party, spoke regarding the City's potential decision to allow Collective Bargaining (Unions). She sited many examples from other cities where allowing this practice has caused problems and higher taxes. City Council recently voted 5-5 on allowing Collective Bargaining, so it didn't pass. Council may place the question on the November ballot as a non-binding referendum to poll the public and then hold another vote afterwards.

#### Officer Reports:

Secretary Report: April 8, 2024 minutes were distributed for approval. A motion to approve the minutes with the removal of "Dick" from the adjournment was made by Kim Lacroix and 2<sup>nd</sup> by Scott Schubert. The motion passed unanimously.

<u>Treasurer's Report:</u> The report was presented by David Albis and accepted. \$15,658.17 total funds in Cape Story Accounts (\$12,779.96 Checking, \$2,878.21 Savings). David reported that there is still trouble collecting about \$4,000 from Oyster Roast online ticket sales. It was discussed and agreed that we should contact a lawyer to pursue collection litigation.

Todd also updated that the current 2040 Comp Plan identifies the intersection of N Great Neck and Shore Drive as a City Center and targets it for high intensity development.
